## SEVENTH AMENDMENT TO AMENDED AND RESTATED MASTER DECLARATION FOR SOLIVITATM

WHEREAS, that certain Amended and Restated Declaration for Solivita<sup>™</sup> was recorded in Official Records Book 9142, Page 1843, of the Public Records of Polk County, Florida, as the same has been amended and/or supplemented (hereinafter referred to as the "**Declaration**"); and

WHEREAS, Developer is desirous of further amending the Declaration; and

WHEREAS, Section 5.3 of the Declaration provides that, prior to and including the Turnover Date, Developer shall have the right to amend the Declaration as it deems appropriate in Developer's sole and absolute discretion, without the joinder or consent of any person or entity whatsoever; and

WHEREAS, as of the date of this Seventh Amendment, the Turnover Date has not occurred.

NOW, THEREFORE, Developer hereby amends the Declaration as follows:

- 1. The above recitals are true and correct and are incorporated herein by reference.
- 2. Unless otherwise defined herein, each term defined in the Declaration and used herein shall have its meaning as defined in the Declaration.

- 3. Section 28.25 of the Declaration is hereby amended to read as follows:
  - 28.25 <u>Transfer Fee</u>. Association has established a Transfer Fee ("<u>Transfer Fee</u>"). There shall be collected upon every conveyance of ownership interest in a Home by an Owner other than Developer or a Builder an amount of two hundred fiftytwo thousand dollars (\$2502.000.00) payable to Association. The Transfer Fee shall not be applicable to conveyances from Developer or a Builder. After the Home has been conveyed by Developer or a Builder there shall be a recurring assessment payable to Association upon all succeeding conveyances of a Home. The amount of Transfer Fee and the manner of payment may be changed by resolution of the Board from time to time; provided, however, all Homes shall be assessed a uniform amount.


